2002 Colorado ChemSweep

Due to previous success and much demand, Colorado ChemSweep, a waste pesticide collection program, is coming again in March of 2002. The registration deadline is February 22, 2002.

Colorado ChemSweep provides an opportunity for unusable pesticides disposed of in an environmentally safe manner. The program is conducted under the "Universal Waste Rule" which allows MSE Environmental, Inc. to go to the site, properly package the waste, take possession of the waste and become the generator of the waste, thus reducing future liabilities for the program participants. The program meets all state and federal hazardous waste regulations.

The approximate cost to dispose of pesticide waste is \$2.25-2.65 per pound. A minimum of \$50.00 (approximately 20 pounds of waste) is required for MSE to make an onsite visit.


Meet the Colorado CCA Board—Jim Sharkoff

Jim Sharkoff has been a Colorado CCA since 1995, and has represented the USDA Natural Resources Conservation Service (NRCS) to the Colorado CCA Board of Certification since 1997. Jim also served as Chairman of the Colorado CCA Board from October 1998 through September 1999.

Jim originally is from Michigan and moved to Colorado with his family in 1968. He graduated from High School in Colorado Springs and started college in the Journalism Department at CSU in 1971. After two years, Jim put his college career on hold and went to work pulling soil samples, selling fertilizer, driving spreader trucks, and scouting fields for US Steel Agrichemicals at Timnath. Jim spent about ten years working for fertilizer and chemical dealers, aerial applicators, and

producers in Northeastern Colorado. In 1985, he was hired by a custom-seeding contractor from Windsor where he spent about 5 years learning the reclamation business. Meanwhile, he re-enrolled at CSU and earned his B.S. and M.S. degrees in Agronomy.

Jim signed on with the USDA Soil Conservation Service in 1991. He spent two years mapping soils on the Western slope, then transferred to an agronomy position in the San Luis Valley where he spent four years demonstrating irrigation, nutrient, and pest management practices. In 1997, Jim accepted the State Conservation Agronomist's position with the NRCS (formerly the SCS) in Lakewood.
