Greetings from your CCA Board!

It seems that midwinter has arrived already. By the disordered state of my Section 18 files, even here in Lakewood I know that spring is rushing towards us! The view westward from my office window today seems to be a repeating theme this winter: a solid blanket of clouds to the west stuck over the edge of the Front Range, with sunny skies and balmy weather even a few miles out onto the plains. I imagine that those of you that live to the west are busy shoveling snow again today, while those of us on the plains are wishing a bit more moisture would manage to make it our way!

This issue of your newsletter includes a 10-year summary of board-approved CEU's. The total number of CEU applications seems to be holding steady in recent years at just under 100, and I am happy to see that last year's offerings in Nutrient Management went back up to a normal level after the previous year's low!

In December I sent a letter to our regional ICCA representatives highlighting your board's opinions on three areas that are under discussion by ICCA:

 We believe that the new ICCA policy for local board structure is too rigid and inflexible, and does not recognize the need for local boards to organize in a way that

- makes sense for their area.
- 2. We believe strongly that postapproval of CEU's by our CCA Board should be allowed.
- 3. An auditor for ASA recently recommended that the basis for calculating overhead expenses for ICCA activities should be changed to include "local board" expenses. This would result in a 74% increase in the amount of funds going as "indirect cost" to ASA. We feel that more justification and explanation is needed for this proposed change.

These are the opinions of your CCA Board. We hope that our opinions reflect those of most Colorado CCA's. We would be happy to hear from any of you regarding your opinions or thoughts on these or other CCA matters.


