
As your advisory board chair, I attended the March ICCA advisory council meeting, along with Merlin Van Deraa, the regional representative to the ICCA Board. Much of this meeting focused on discussions with a representative from USDA regarding the Technical Service Provider (TSP) program. We also arranged to have a Colorado CCA who is also a TSP (Brad Walker) attend this meeting to participate in this discussion with USDA. Seems this program still has a number of bugs that need to be worked out.

A proposal was also discussed at the ICCA meeting to create various specialties (such as nutrient

management, conservation, irrigation) to the basic CCA certification. The ICCA advisory council seems to be fairly evenly split on this issue, and no action was taken. Merlin and I both opposed it. since we feel that a Colorado CCA has already demonstrated his qualification for most the areas suggested. This is an area where we would welcome hearing the opinions of other CCA members.

I have promised to avoid using this forum as an opportunity to preach about pesticides. But since I am the one who submits section 18 requests to EPA and also am responsible for ensuring compliance with the section 18 conditions. I just can't resist one little reminder! If you recommend a section 18 pesticide product to a customer, or make your own applications as a commercial applicator, please remember each user must obtain a permit from the pesticide section of the Colorado Department of Agriculture, and each applicator must have a copy of the section 18 use directions with them during application! There, I feel better! Thanks for your patience, and have a good summer!

Results of 2004 CCA Exams

Eleven individuals took the Colorado CCA exam February 6, 2004 at the Adams County Fairgrounds near Brighton, CO. The passing score was 75. 55 percent of the people who took the state exam passed.

The next exam will be held February 4, 2005. Registration must be received at ASA by December 17, 2005. Exam registration materials are available by contacting ASA at 608-273-8085 or by email at cca@agronomy.org.

Who Determines Performance Objectives? CCA's Do

Passing the state and international CCA exams is one of three qualifications necessary to become certified. The purpose of the exam is to ensure that all entering CCA's have a base knowledge of agronomic principles in the four competency areas: Soil Fertility, Soil and Water Management, Integrated Pest Management and Crop Management. The required knowledge base is described in the Performance Objectives (P.O.). A question that often arises is "Who comes up with these P.O.s and decides what a CCA should know?" The answer to that question is CCA's decide. More accurately, your state and international boards determine the content and wording of the P.O.s through much work, debate and revision. In Colorado, the exam subcommittee, with suggestions from the Board, reviews one section of the P.O.s per year. These suggested revisions are presented to the whole Board at the spring meeting. Each P.O. is voted upon after consensus is reached on content and wording. Exam questions are then written or edited to reflect the changes in P.O. wording. These questions are again voted upon by the entire Board, usually at the fall meeting.

You have the opportunity to influence this process in a couple of ways. First, you can contact any state board member and provide your suggestions for improving the P.O.s at any time. They will pass along that information to the sub-committee and it will be incorporated in the next review. The Board has also decided to conduct a mailed survey of Colorado CCA's regarding the entire P.O. document. This survey will probably be conducted in late 2004 and allow for direct input from a larger group of CCA's. The Board encourages your participation in this process.

One point on the P.O. document to remember is that individual P.O.'s should no longer be used to develop continuing education or apply for CEU's. The ICCA Board took this step to discourage continuing education that duplicates

knowledge that a CCA should already have.

Section 18 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) authorizes the EPA to allow States to use a pesticide for a limited time if EPA determines that emergency conditions exist. The uses are requested for a limited period of time, to address the emergency situation only.

Section 18 emergency exemptions are used when there are no other federally registered pesticides available to control a serious pest problem and there would be significant economic loss without the use of the Section 18 pesticide.

Section 18 uses are restricted for retail sale to and use only by certified applicators or persons under their

direct supervision. Pesticide applicators must have and follow the Section 18 use directions as well as the EPA-registered label at the time of application.

A permit is required from the Colorado Department of Agriculture (CDA) in order to use a Section 18 product. There is no charge for this permit.
