Welcome New CCAs in Colorado

We congratulate each of you on becoming a Certified Crop Adviser (CCA). You have demonstrated your knowledge in this profession and have signed the Code of Ethics. The most important requirement in maintaining your certification is that of continuing education. One of the purposes of this newsletter is to inform you of training opportunities to consider.

Continuing Education Program

Continuing education is the lifeblood of any professional. Change is around us every day, especially in agriculture, but it is hard to evaluate the impact of change on our daily work. Attendance at various meetings and workshops will help. Reading technical and trade journals is a means of self education. The Continuing Education Program is aimed at improving our discipline in continuing this educational process as we go about our business. It also tells others we have committed ourselves to this process during our busy professional lives. This program is very important in maintaining your certification. Everyone's cooperation will make this process of obtaining Continuing Education Units (CEUs) much easier. Suggestions to improve the process or other communications can be given to any member of the CCA Board.

If you know of other upcoming meetings which may contain educational sessions, please ask the vendor (sponsor) to apply for CEUs. As a reminder, Colorado CCAs can earn CEUs for attending educational sessions given in all adjoining states, if the courses have been approved by their respective CCA Boards. Applying for Continuing Education Units (CEUs) for Certified Crop Advisers (CCAs) in Colorado

- 1. Meeting or workshop vendors (sponsors) should apply in writing to the Colorado CCA Training Committee for CEUs at least 15 days prior to the event.
- 2. Forms for this application are available upon request from CSU Cooperative Extension (phone 970-491-6201, fax 970-491-2758) or from the CCA Board members. Separate forms should be completed for each half-day session.
- 3. The completed application forms should be submitted along with a copy of the printed program, if available, giving the time of each presentation. A list of each speaker and a brief summary of the speakers' credentials also is required.
- 4. The Training Committee will approve the appropriate number of CEUs in each competency area. The number of CEUs granted per topic is related to contact time as follows: 30-45 minutes = 0.5 CEU, 46-75 minutes = 1.0 CEU, and 76-105 minutes = 1.5 CEUs.
- 5. Official attendance sheets for each session will be sent by the National CCA office to the meeting vendor.
- 6. The CCAs attending each session must sign the attendance sheets. The meeting vendor is responsible for sending the original sheets to the National CCA office, and for keeping duplicate copies in case the originals are lost in the mail.
- 7. If a vendor expects attendees from more than six states at a given meeting, the vendor should apply for National CEUs instead of Colorado CEUs at least 6 weeks prior to the meeting. The application should be sent to:

Results of the August 1996 CCA exams

By now, all CCA applicants should have received their test scores from the National CCA office. If you know of anyone who has not received notification, ask them to call the National CCA office (number given earlier). Colorado had 24 applicants take the National CCA exam and 25 applicants take the Colorado exam. At this time we don't know how the Colorado applicants fared on the National exam, but 48% of those applicants passed the Colorado exam. The passing score was 70%, the same as for the two previous Colorado exams.

A Reminder to all CCAs Certified Prior to July 1, 1995

This notice is to remind each CCA to check the certification date on your certificate. If you were certified prior to July 1, 1995, your 2-year cycle for earning 40 CEUs expires on June 30, 1997! Remember that you must have at least five CEUs in each category. At least 20 CEUs must be Boardapproved CEUs, while the remaining CEUs can be Board-approved or self-directed.

All CCAs If you have not sent the brown sheets for self-directed CEUs or the green sheets for Board-approved CEUs prior to March 1, 1996 to the National CCA office, please do so as soon as possible. All Board-approved CEUs earned after March 1, 1996 should have been registered at the National CCA office if you signed an official attendance sheet at a meeting. Check your quarterly CEU report carefully to verify that you are receiving the proper credit. Proposed State Management Plans for Five Herbicides

Most of you have heard of the proposed EPA rule concerning establishment of State Management Plans (SMPs) for the use of alachlor, atrazine, cyanazine, metolachlor and simazine. As proposed in the Federal Register on June 26, 1996, SMPs would be required for their use at some point in the future. These herbicides were selected because of their potential to adversely affect groundwater quality. These herbicides have substantial use in Colorado, so there is considerable interest in this proposed regulation. Interested individuals and organizations are encouraged to comment on this proposed rule prior to October 24, 1996.
